

By use of this ticket, the ticket holder, on behalf of the ticket holder and any minor accompanying the ticket holder (individually and collectively, the Holder), agrees that: This ticket is valid only for the event and related activities for which this ticket is issued (Event), as specified on the ticket face. Tickets reported as lost or stolen may not be honored or replaced, nor the purchase price refunded. This ticket may not be used for any commercial or trade purpose, including, but not limited to, advertising, promotions, contests or sweepstakes, without the express written consent of the ticket issuer or arena management. This ticket is a revocable license. Arena management may revoke the license granted by this ticket at any time and for any reason. This includes the right, without any refund of the purchase price, to refuse admission or eject any person: (i) who appears intoxicated; (ii) who fails to comply with arena rules or applicable law, or (iii) whose conduct is deemed by arena management to be disorderly, offensive, abusive, or unsafe. Smoking is prohibited in all areas of the arena. Breach of all legal remedies available to arena management, Event Participants (as defined below), or their respective affiliates. Event Participants means the players, participating clubs, leagues of which the participating clubs are members, talent, acts, promoters or other persons or entities performing or promoting the Event. Any non-licensed individual who resells or offers to resell this ticket is subject to arrest and prosecution under Massachusetts law, and this ticket may be revoked without refund or other compensation. Holder agrees not to transmit, distribute, or sell (or aid in transmitting, distributing or selling) any information about the Event, including but not limited to any description, account, picture, video, audio, or other reproduction or information concerning the Event in any form (Event Information). All copyrights, trademark rights and other proprietary rights in and to (i) the Event, (ii) the Event Information, and (iii) name, marks and logos of the Event Participants are the exclusive property of such Event Participants or their designees or licensors, as applicable, and any unauthorized use of any of the foregoing is strictly prohibited. Holder grants permission to arena management, the Event Participants and their respective affiliates (and their respective sponsors, licensees and agents) to use Holder's image, likeness, actions, voice and statements in any live or recorded audio, video, or photographic display or other broadcast, transmission, exhibition or reproduction made of or at the Event for any purpose without authorization or compensation. **HOLDER VOLUNTARILY ASSUMES ALL RISK AND DANGER OF INJURY INCIDENTAL TO THE EVENT**, including but not limited to injury by sports equipment (including hockey pucks or sticks or lacrosse balls or sticks), by players, talent or other spectators, or by damaged dashers, glass or other Event staging. Holder agrees that the arena owner and operation, the Event Participants, and their respective affiliates, officers, players, employees or agents, are not liable for, and are released by Holder from, injury or other claims arising from such causes. Holder voluntarily assumes the risk of lost, stolen, or damaged personal property. **WARNING!** Pucks, balls and other objects may fly into the spectator area and can cause serious injury. Be alert in the spectator area during all on-ice or on-field activity. If struck, immediately ask an usher for directions to a medical station. Arena management reserves the right to prohibit Holder from bringing into the arena: bags, luggage, coolers, parcels, briefcases and like articles; umbrellas; signs, flags or banners; alcoholic beverages; bottles, cans or containers; laser pointers; irritants (e.g., artificial noisemakers); videotape cameras; strobe-lights; or any item deemed by arena management to be a weapon. Promotional items with commercial slogans or identification are prohibited in the arena unless distributed or sold by arena personnel or Event Participants. For security purposes, all persons and possessions are subject to search by arena security personnel, and Holder consents to such search. Ticket holders with prohibited items will not be permitted entry into the arena, and no storage area will be provided for such items. Re-entry to the Event is not permitted. No signs, flags or banners may be

The Holder agrees that this ticket license is subject to these terms and conditions, as well as any additional terms and conditions established by the Boston Bruins and/or its affiliates (the "Team"), the National Hockey League and/or its affiliates (the "NHL"), and any operator of the arena or related arena grounds (including, without limitation, parking areas and entry gates) (the "Arena") at which the event or any surrounding activities (in whole or in part) for which this ticket is issued (the "Event") is held (collectively, all such additional terms, "Supplemental Terms"). By acceptance and/or use of this ticket and/or entering (or seeking entry into) the Arena, the Holder is deemed to have read all such terms and agreed to be bound by them.

3. Due to the uncertainty related to the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, collectively, "COVID-19"), this ticket and the Holder's admission to the Arena are subject to all safety and health requirements and policies put in place by the Team, NHL, and Arena, including any requirements relating to facemasks and/or enhanced health screenings (which may include a requirement that the Holder, and any person for whom the Holder obtains a ticket or is in the Holder's party, be tested for and/or vaccinated for COVID-19 prior to the Event) and those policies and requirements described in the Supplemental Terms. Such policies and requirements as they may be updated from time to time (in the sole determination of the Team, NHL and/or Arena) and as they may be communicated to the Holder prior to or during the Event (whether orally or in writing) by, for example, instruction provided by Team or Arena personnel or signage in or around the Arena, are collectively referred to below as the "Safety Requirements". The Holder acknowledges and agrees to comply with the Safety Requirements (including all requirements that must be satisfied prior to or during the Event), and

acknowledges and agrees that attendance at the Event is conditioned on such compliance.

The Holder agrees, on behalf of the Holder and Holder's Related Persons (defined below), that the Holder and each such individual will not attend the Event if, within the prior 14 days, any such individual has tested positive for COVID-19, or, unless fully-vaccinated for COVID-19 (as defined by the Centers for Disease Control and Prevention ("CDC")), any one or more of the following is true on the day of such Event:

- Within the prior 14 days, any such individual was exposed to someone who has tested positive for COVID-19;
  - Within the prior 14 days, any such individual has travelled to a state or international territory identified by federal or applicable local governments as being subject to travel or quarantine advisories due to COVID-19; or
  - Within the prior 48 hours, any such individual has experienced symptoms of COVID-19 (e.g., a fever of 100.4°F or higher, cough, shortness of breath or difficulty breathing, chills, repeated shaking, muscle pain/achiness, headache, sore throat, new loss of taste or smell, nasal congestion, runny nose, vomiting, nausea, diarrhea, fatigue or any other symptoms associated with COVID-19 identified by the CDC ("COVID-19 Symptoms")).
- Anyone who is fully vaccinated but experiences any of the COVID-19 Symptoms identified above within the 48 hours prior to the Event should nevertheless consult a healthcare provider and receive a negative test result for COVID-19 before attending the Event.

To ensure that all Event patrons agree to, and comply with, all Safety Requirements and all other NHL, Team and Arena rules, this ticket may not be resold or offered for resale on any platform other than a platform expressly authorized by the Team or the NHL. Without limiting the foregoing, any transfer of this ticket to any person who fails to satisfy any Safety Requirement (including pre-Event requirements established by the Team or Arena) may be voided by the Team and this ticket cancelled.
