

Official Rules

1. General. By submitting an entry to this TD Garden ProShop Playoff Pack Sweepstakes, sponsored by Delaware North Companies, Inc.-Boston ("DNCB"), ("the Sponsor"), the entrant acknowledges and agrees to all of these Official Rules. Void where prohibited. The TD Garden ProShop Playoff Pack Sweepstakes begins at 4:30 p.m. Eastern Time on Wednesday, May 11, 2022 and ends at 4:30 p.m. Eastern Time on Thursday, May 12, 2022 ("the Sweepstakes Period"). By entering the drawing, entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are in its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Sweepstakes.

2. Eligibility. The Sweepstakes is open only to legal U.S. residents within the continental United States who are 18 years of age or older as of Wednesday, May 11, 2022. Employees of the Sponsor and Delaware North Companies, Inc. - Boston ("DNCB") and their respective parent companies, subsidiaries, and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are not eligible.

3. How To Enter. No Purchase Necessary. There is one (1) method of entry for the Sweepstakes. In order to participate, you must be a registered user on Twitter.com and follow @TDGarden on Twitter. During the Sweepstakes Period, Sponsor will send a "tweet" from the handle @TDGarden asking users to retweet (the "Sweepstakes Tweet") on Twitter.com. To enter, you must retweet the Sweepstakes Tweet using the retweet function within Twitter.com from your Twitter account during the Sweepstakes Period. An entry received outside of the Sweepstakes Period will be deemed ineligible.

To "follow" @TDGarden on Twitter.com, log in to your Twitter account and select "Find People" from the tool bar at the top of the homepage. When the search box appears, enter "@TDGarden" and then click on the "Search" button. Select "Follow" when the @TDGarden icon appears.

Limit one (1) entry per person. Additional entries will not be acknowledged.

4. Selection of Winner. One (1) Winner will be selected from all eligible entries received during the Sweepstakes Period in a random drawing to be conducted within approximately three (3) days following the close of the Sweepstakes Period. The winner will be contacted via direct message on Twitter within that time frame. The Sponsor's decisions are final, binding, and conclusive on all matters related to the Sweepstakes. 8. Disputes/Choice of Law.
