

OFFICIAL RULES

1. GENERAL: NO PURCHASE NECESSARY TO ENTER TO WIN. By submitting an entry to this sweepstakes, sponsored by Delaware North Companies, Inc.-Boston ("DNCB"), ("the Sponsor"), the entrant acknowledges and agrees to all of these Official Rules. Void where prohibited. The My Chemical Romance Sweepstakes begins on Thursday, September 1, 2022, at 9:00 a.m. and ends Friday, September 2, 2022, at 5:00 p.m. All times in this sweepstakes refer to Eastern Time. By entering the drawing, entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this sweepstakes.

2. ELIGIBILITY: The sweepstakes is open only to legal U. S. residents of MA, CT, NH, RI, VT and ME who are 18 years of age or older as of Thursday, September 1, 2022. If winner selected is under 18 years of age, the prize will be awarded to the winner's parent or legal guardian. Parent or legal guardian must be 18 years of age or older as of Thursday, September 1, 2022. Employees of Sponsor and their respective parent companies, subsidiaries, and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are not eligible.

3. HOW TO ENTER: No Purchase Necessary. There is one (1) method of entry for the Sweepstakes. In order to participate, you must be a registered user on Twitter.com and follow @TDGarden on Twitter. During the Sweepstakes Period, Sponsor will send a "tweet" from the handle @TDGarden asking users to retweet (the "Sweepstakes Tweet") on Twitter.com. To enter, you must retweet the Sweepstakes Tweet using the retweet function within Twitter.com from your Twitter account during the Sweepstakes Period. An entry received outside of the Sweepstakes Period will be deemed ineligible.

To "follow" @TDGarden on Twitter.com, log in to your Twitter account and select "Find People" from the tool bar at the top of the homepage. When the search box appears, enter "@TDGarden" and then click on the "Search" button. Select "Follow" when the @TDGarden icon appears.

Limit one (1) entry per person. Additional entries will not be acknowledged.

4. If the winner is not responsive within 24 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternate winner selected.
